ELLIOTT HOUSE VISITORS THIS WEEK

This year we welcome clergy and theological students to the Eleventh Annual Elliott House Clergy Seminar, on texts of Erasmus, Luther, and Hooker, conducted by Neil Robertson, Professor of Humanities at King's College, Halifax, and adjunct professor in the Classics and in Political Science at Dalhousie University.

ONE BODY?

In Epiphany we celebrate the manifestation of Christ to the Gentiles, the conversion to Christ of all sorts and conditions of men, and their incorporation into the fellowship of his Body the Church. That there is "one Mediator of God and men, the man Christ Jesus, who gave himself a ransom for all" (1 Timothy 2:5, 6), implies that "that he should gather together *into one* the children of God that are scattered abroad" (John 11:52).

As to unity, however, the Church Catholic does not present an impressive picture. The ancient churches of the East remain divided from the ancient churches of the West; the Western church is divided between Roman Catholics and Protestants (who are divided among themselves), and in the Global South large and growing Pentecostal churches regard older traditions without sympathy. When we turn to Anglicanism, we find a notorious (or boasted or merely puzzling) medley of evangelical, catholic, charismatic, liberal, and conservative. In the wake of 19th century party warfare between evangelical and catholic, liberal ideas gained ascendancy, but since the

1970's this liberal tendency has itself become divisive, pursuing its own agendas - in liturgy, ordained ministry, the language of revelation, and marriage - at the cost of the church's unity. An exodus of exasperated conservatives has not slowed the pursuit of this agenda.

I know the previous paragraph was depressing to read - I made it as short as possible - but the rehearsal of this history does have this salutary effect, that we not take for granted such unity as we do have. Differences of churchmanship, personality, mission, theology, practice, and so on, are inevitable, and even enriching - but only if they are held within commonly-accepted parameters. Accepting the limits upon what we would like to do, expressing our differences with self-restraint, is necessary to living as a church. The question is, where do we find these parameters?

At its organization after the Revolution the Episcopal Church took a high view of the "liberty wherewith Christ hath made us free" (Galatians 5:1): "in [God's] worship different forms and usages may

without offence be allowed, provided the substance of the Faith be kept entire” (*Preface* of 1789, Prayer Book, p. v). Nonetheless, though the American church departed somewhat from the 1662 Prayer Book and 39 Articles of Religion in its revisions of 1789, 1893, and 1928, it did not depart very far. Notably, after protests from minorities and from partner churches at its omission, the Nicene Creed was retained.

In practice, therefore, the Episcopal Church’s use of liberty was governed by self-restraint, with special regard not only to “the substance of the Faith” but also in regard to shared inheritance of “forms and usages”. Such self-restraint is not a restriction on Christian freedom: “for, brethren, ye have been called unto liberty; only use not liberty for an occasion to the flesh, but by love serve one another” (Galatians 5:13). Liberty without love is merely license “to bite and devour one another” (5:15). The historic autonomy of the Episcopal Church is not absolute but (as the Windsor Report called it), “autonomy-in-relation”, an interdependent autonomy self-limited and responsive to its partner churches in matters affecting the common inheritance.

This understanding of liberty appears in the Preamble to the Constitution of the Episcopal Church, which though brief nonetheless commits the Episcopal Church to being “a constituent member of the Anglican Communion” defined as “a Fellowship ... of churches in communion with the See [i.e. the Archbishop] of Canterbury, upholding and propagating the historic Faith and Order as set forth in the Book of Common Prayer”. Though no edition is

specified, the only edition for which this claim could be made (at least in a historical sense) is that of 1662, and (by derivation) its local adaptations (such as 1928). As preamble to the Constitution, this commitment governs (and overrides) the authority of the General Convention and its canons. Both in the larger church, and in the parish, to live at unity within those parameters is both our privilege and our vocation. GGD
